Market Overview

Goldman Sachs Dynamic Opportunities Limited ("GSDO" or the "Fund") generated negative performance of -1.21% (US Dollar, net of fees) in November, as the majority of managers contributed negatively.

The Equity Long/Short sector was the weakest sector in November as all but one manager generated negative performance. The Europe-focused manager generated positive performance as both long and short positions contributed positively and gains were only partially offset by losses from index hedging positions. Long positions in the consumer staples and industrial sectors were among the largest positive contributors to performance. Underperforming managers generally lost from long positions with detractors primarily in the financials, technology and consumer sectors. Short positions broadly contributed positively but were not able to offset the losses from long positions. Additionally, managers who maintained conservative positioning into the month-end equity market rally generally failed to fully recapture losses from earlier in the month.

The Event Driven sector also detracted from performance in November as all managers finished the month with negative or flat performance. Credit managers with more directional exposure and a higher allocation to listed and post reorganization equity positions generally experienced the largest declines. Conversely, managers with more balanced exposures experienced flat performance. Multi-strategy manager exposure to catalyst-driven and special situation equity positions detracted from performance. Additionally, some managers had allocated to credit investments that had sold off significantly in August and September, which underperformed again during November following some recovery in October and contributed to losses. There was limited attribution for multi-strategy managers, positive or negative, from significant idiosyncratic developments.

The Fund's Relative Value manager generated negative performance in November as losses in the long portfolio outweighed gains from short positions. Losses were driven by long positions in a Brazilian media company, a Middle Eastern financial services firm and a Middle Eastern telecom company. Among the largest positive contributors were short positions in a private education company in China and a long position in a Russian telecom company.

The Tactical Trading sector also contributed negatively in November as the Fund's fundamental commodities manager generated negative returns, macro manager performance was mixed and the systematic trading manager contributed positively. The fundamental commodities manager generated negative performance across all commodity sectors except for energy, which was flat. The largest detractors over the month were both long and short positions in the agricultural sector. The systematic trading manager on the other hand generated positive performance as gains from commodities trading exceeded losses from currencies and equities. Macro managers generated the largest gains in fixed income trading as most managers retain long positioning. Performance in currencies was mixed, as macro managers are divided between longer-term structural short positions in the U.S Dollar and more tactical long positions. Risk in commodities and equities remains low and mixed, which resulted in muted, mixed performance.

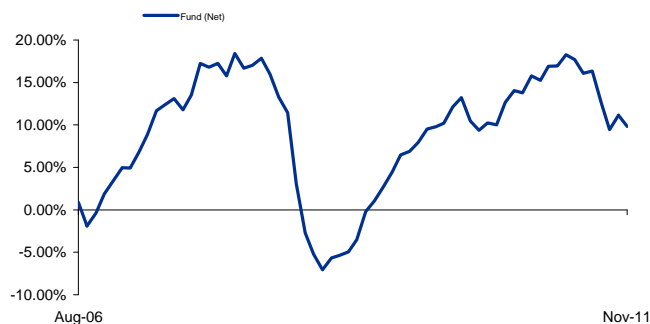

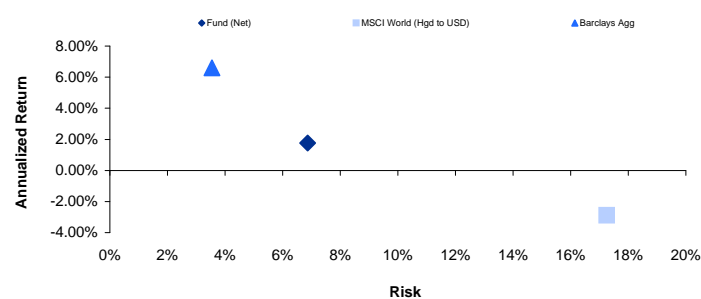

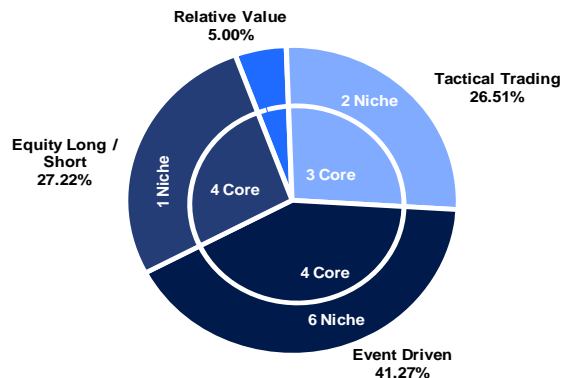

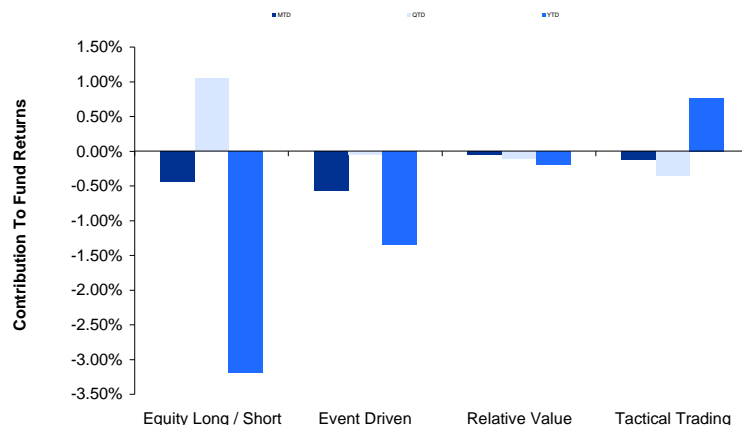

Effect of fees on performance:

The following table provides a simplified example of the effect of management and incentive fees on portfolio returns. For example, assume a portfolio has a steady investment return, gross of fees, of 0.5% per month and total management fees of 0.1250% per month of the market value of the portfolio on the last day of the month and incentive fees of 10% of net profits. Management fees and incentive fees are deducted from the market value of the portfolio on that day. There are no cash flows during the period. The table shows that, assuming that other factors such as investment return and fees remain constant, the difference increases due to the compounding effect over time.
