Market Overview

Goldman Sachs Dynamic Opportunities Limited ("GSDO" or the "Fund") generated negative performance of -2.82% (US Dollar, net of fees) in September as the majority of managers detracted.

Equity Long/Short managers experienced negative performance in September. Underperforming managers generally maintained risk in high conviction cyclical names and emerging market countries. Long exposure to financials and cyclical sectors such as industrials, energy, and materials were the largest detractors in September. Managers with more moderate losses generally reduced risk in response to market volatility, with many rotating away from economically sensitive names by moving long exposure out of cyclical sectors into more stable sectors such as consumer staples. Managers generally continued to decrease risk by adjusting both gross and net exposures, with some adding single stock short exposure and hedging positions.

The Event Driven sector also detracted from performance in September as all managers generated negative performance. Credit focused managers generally experienced losses, although managers with smaller equity exposures, more balanced exposures and trading-oriented styles fared better. In terms of price action during the month, initial trading in credit during the month resulted in muted losses. However, macro headwinds overwhelmed the markets and accelerated losses into month end. Multi-strategy managers experienced losses across both credit and equity positions during September despite a general risk reduction in August. Some managers had attempted to further hedge equity market exposure during August, but the selloff in the markets dominated the portfolios causing losses during September. Merger arbitrage exposure was generally a small contributor as some deal spreads tightened modestly and other deals approached completion. While managers remain cautious, they continue to highlight the increased opportunity set stemming from the recent market dislocation.

The Fund's Relative Value manager also generated negative performance in September. Losses from long positions were only partially offset by gains from emerging market index positions and gains from short positions in Western Europe. The largest detractors included long positions in European industrials, and Eastern European and Latin American telecoms.

The Tactical Trading sector was the only sector with flat performance in September as gains from macro managers overall and positive performance from the fundamental commodities manager offset the losses from the Fund's systematic trading manager. Macro trading in fixed income contributed positively as long positions in U.S. and non-peripheral European government bonds benefited from a decline in yields. Trading in currencies was negative due to a strong U.S. Dollar rally. Commodities also detracted from performance, notably energies and precious metals, while equities were mixed. The Fund's fundamental commodities manager contributed positively as performance was positive across energy trading, a number of agricultural commodities and portfolio hedges, while only long positions in grains detracted. The Fund's systematic trading manager detracted in September as positions in commodities, currencies and equities all detracted and only fixed income positions generated gains.

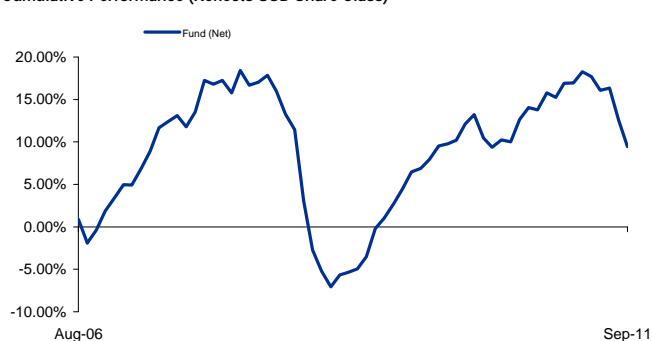

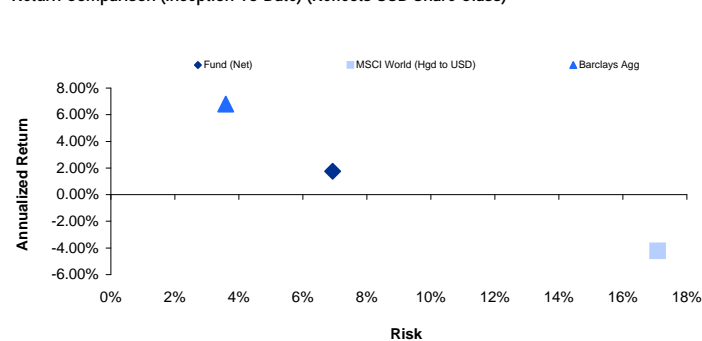

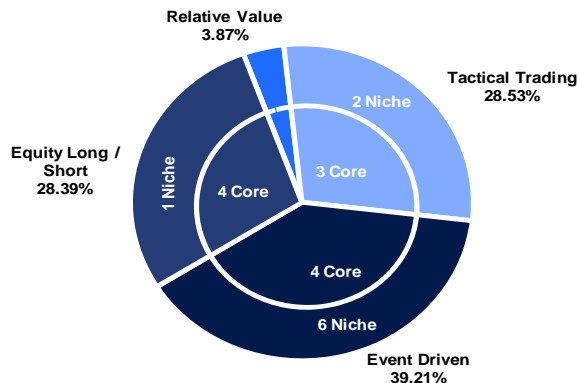

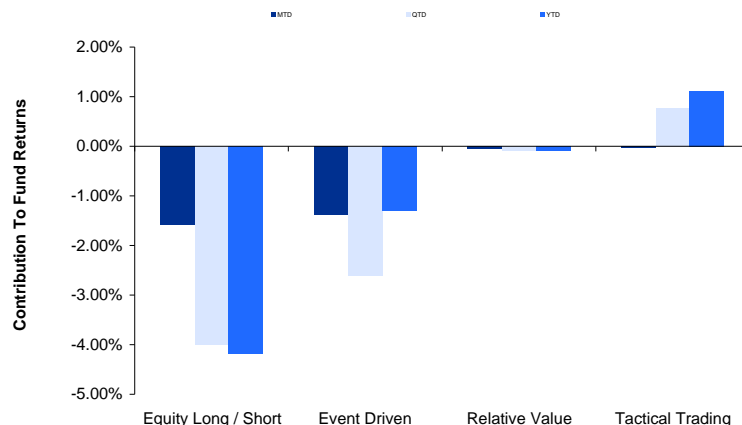

Effect of fees on performance:

The following table provides a simplified example of the effect of management and incentive fees on portfolio returns. For example, assume a portfolio has a steady investment return, gross of fees, of 0.5% per month and total management fees of 0.1250% per month of the market value of the portfolio on the last day of the month and incentive fees of 10% of net profits. Management fees and incentive fees are deducted from the market value of the portfolio on that day. There are no cash flows during the period. The table shows that, assuming that other factors such as investment return and fees remain constant, the difference increases due to the compounding effect over time. Of course, the magnitude of the difference between gross-of-fee and net-of-fee returns will depend on a variety of factors, and the example has been intentionally simplified.
