On November 7, 2008, Presbyterian Intercommunity Hospital, Inc. (the "Borrower") released a Disclosure of Intent to Bid (the "Notice") as a preliminary statement of the Borrower's intent to bid on the bonds referenced above (the "Bonds") in the auction to be held on November 14, 2008 (the "Auction"). The purpose of this Post-Auction Disclosure is to supplement the Notice with certain bid results of the Auction.

Post-Auction Disclosure Is Hereby Given That:

- (1) On Friday, November 14, 2008 the Borrower submitted a bid in the Auction to purchase \$7,075,000 of Bonds subject to auction. The Borrower bid an interest rate of 1.39% which was the then current SIFMA Municipal Swap Index of 1.14% plus 25 basis points. The Borrower was able to purchase \$2,200,000 of the Bonds available at Auction. The Borrower presently intends to submit Hold Orders in subsequent auctions with respect to the Bonds which it owns.
